At 5:34pm on Nov. 1, a deputy arrived at a property where a caller said he had been forced to leave a trailer when his truck broke down during a landscaping job. The caller said an associate of the property owner was now holding the trailer as collateral for debt owed by another worker, as well as trying to sell the trailer. The deputy called the associate, who admitted the trailer was in a barn on the property. The deputy advised it was a poor decision to hold the trailer as collateral and that he should come to the property to release it to the caller. The associate refused and said the caller would have to come back another time. The associate then hung up and refused to answer further calls. The deputy advised the caller that because the trailer was on private property, neither the deputy nor the caller could retrieve the trailer without permission and it was now a civil matter.

MESSAGE FROM THE SHERIFF

This month I'm proud to tell you about the North Starrys, a hockey team made up of first responders including Sheriff's Office staff as well as police officers, firefighters and EMS from departments throughout Washington County. We're gearing up to join other teams from around the state at the 8th annual Big Bear Hockey Classic in April.

This event began as a way to honor Brooklyn Park Officer Andy "Big Bear" Suerth, who died suddenly in 2017. The first Big Bear Hockey Classic was held in 2019, and to date the event has raised \$92,000 for first-responders and their families in need of financial support as they face medical battles or deal with family loss.

Our own Deputy Chris Majeski has been chosen as the beneficiary of the 2026 Big Bear Hockey Classic. Deputy Majeski continues to battle metastatic oropharynx, or throat cancer. This condition is considered incurable but can be treated with various options to manage symptoms and improve quality of life. Deputy Majeski, who has been with Washington County Sheriff's Office since 2003 in various roles — including stints as the Scandia contract deputy, a K9 handler and a dive team member — continues to work on patrol as a field training officer despite his health challenges. We greatly admire his determination and dedication, as well as the example he sets for his fellow deputies.

Besides the Big Bear tournament, the North Starrys also play non-competitive pick-up games throughout Washington County, typically bi-weekly.
