Those present included: Board members John Adams, John Pazlar, and Steve Magner; Interim Clerk/Treasurer Marsha Olson and Interim Deputy Clerk/Treasurer Linda Tibbetts. Chair Adams called the meeting to order at 3:00 p.m.


Adams moved, seconded by Pazlar, to offer employment of Clerk/Treasurer to Bobbi Hummel, with benefits. By Roll Call Vote: Adams: YES; Pazlar: YES; Magner: YES. Motion passed.


Tibbetts provided Resolution 2022-10 for review that would allow Tibbetts to continue signing checks at the township's designated bank until such time the Clerk/Treasurer is up and running. Adams moved, seconded by Pazlar, to adopt Resolution 2022-10, a resolution to appoint interim Clerk/Treasurer and authorize signature status for fund accounts, as presented. By Roll Call Vote: Adams: YES; Pazlar: YES; Magner: YES. Motion passed.
